To whom it may concern:

Eurotherm Ltd Statement on ‘The Waste Batteries and Accumulators Regulations 2009’

Following an in house review of the usage of batteries in Eurotherm products the following understanding was developed:

- Eurotherm does include batteries in the majority of product ranges that are placed on the UK market.
- These batteries are sourced from a variety of vendors. The vendors include UK based distributors for batteries, batteries already fitted to PCB's sourced from UK manufactures and sister companies based outside of the UK. The source varies through demand and capacity.

Following consultation with an Environment Agency representative the following clarification on the legislation has been provided:

- Any material we receive from a distributor with a UK address is the responsibility of our supplier.
- Material we receive as subassemblies (PCB's) with a battery is the supplier's responsibility if they have a UK address. If we have a contract with an overseas supplier directly with no UK representation the responsibility becomes Eurotherm's as the first company to place the items on the UK market.
- Assemblies we receive from sister companies overseas and place on the UK market are our responsibility.

Taking our battery usage and the guidance received from the Environmental Agency into account the following actions have been taken:

- Eurotherm places on the market less than 1 Tonne of batteries per year and has therefore registered as a producer on the Environmental Agency website.



- Eurotherm will provide the Environmental Agency with data on the amount of batteries placed on the market annually by the end of each compliance year.
- Eurotherm will pay the £30 registration fee, and the ongoing registration costs.
- Eurotherm will continue to monitor its batteries usage with regard to the 1 Tonne limit and should the types of battery placed on the market change within a year will be in a position to update the Environmental Agency as required.
